For the 540th issue of Headlines Himalaya, we reviewed 16 news from 10 sources and selected 15 happenings from five countries. Police have arrested four people for illegal possession of wildlife parts in eastern and central Nepal. The increasing anthropogenic activities has led to destruction of chure and mahabharat range of Dang, south western Nepal. The Government of Nepal has developed the Red Panda (*Ailurus fulgens*) Conservation Action Plan for 2019-2023. A man with possession of deer (*Cervidae*) hide was arrested in Silichong Rural Municipality-3 of Sankhuwasabha district, eastern Nepal by Police. Similarly, police arrested three people with leopard (*Panthera pardus*) skin from Bhugol Park in Kathmandu Municipality, Central Nepal. The arrested will be tried under the National Park and Wildlife Act 1973.

CHURE AND MAHABHARAT RANGE ON THE VERGE OF DESTRUCTION

The increasing anthropogenic activities including cement factory, sand mining, stone extraction and misuse of natural resources in the Chure and Mahabharat range has led to overexploitation of natural resources and dying of water sources in Dang, south western Nepal. Plans are being made for the conservation and sustainable use of natural resources by the District Coordination Committee, Dang.

ACTION PLAN TO CONSERVE RED PANDA DEVELOPED

The Government of Nepal has developed the Red Panda (*Ailurus fulgens*) Conservation Action Plan for 2019-2023. The plan aims to protect and manage the species population in Nepal through integrated approach of conservation including research, monitoring, awareness building, habitat improvement, and threat management. Despite being listed as endangered species on IUCN Red List of Threatened Species, they are vulnerable to illegal trade, poaching, habitat loss and other anthropogenic activities.

CONSERVATION AND RESTORATION OF WULAR

Wular Conservation and Management Authority is carrying out conservation and eco-restoration of Wular Lake, Jammu and Kashmir, northern India which is one of the largest fresh water lakes in Asia. The lake is also declared as Ramsar site. The Governor of Jammu and Kashmir has advised the concerned authority to enhance the water holding capacity of the lake and its rejuvenation. In addition, ecotourism and generation of livelihood opportunities from the lake are essential as per the comprehensive management action plan.

CONSTRUCTION OF LAWA HYDROPOWER STATION

In order to increase renewable energy supply and boost local development, China's top economic regulator has approved the construction of the Lawa hydropower station along the Jinsha River, in the junction of Sichuan province, and the Tibet autonomous region in south western China. With the investment of USD 4.59 billion, the project will also improve the region's flood control capacity and water transfer capacity.

MINING EXPLORATION THREATENS FOREST PROTECTION
